4 Chair's report (RW): see report of 26 October

5 Committee numbers/Diversity (RW)

Three places to fill; need for quorum at meetings; need expressed to diversify membership particularly with age and origin profile of the Kentish Town ward is a vis the current committee profile; suggestions for new members included contacts of committee.

ACTION: Fabrizio to draft an ad for distribution on Twitter, Facebook and other media, prior to AGM in January

6 Air pollution on Kentish Town Road (KTRA)

Presentation from Rachel Wrangham, Lindsay Purchall and Caroline Hill; Rachel outlined the current situation in Kentish Town Road, with sites over legal minimum for NO2, even in side streets. Lindsay said aim was to reduce pollution, congestion and noise with ideas on reducing number of delivery vehicles, local congestion charge, penalty charges for polluting cars, vehicle idling controls and business parking permits. Caroline stressed joined-up action between Neighbourhood Forums, and contacting Camden's Air Quality Scrutiny Committee.

ACTION: Roger to send Caroline details of other Neighbourhood Forums to contact. KTNF agrees to consider air pollution whenever a planning application is considered, and in particular stress the least polluting boilers in new developments.

7 Updates

Carpetright and Pizza Express sites (VB)

Carpetright 152-156 Kentish Town Road: recent application to discharge planning conditions from subsidiary of Sports Direct; Planning Ref: 2017/6126/P ACTION: Virginia to keep watch on this development; Paul to search Land Registry on it

Pizza Express: owners of the site unable to sell at current price; their position – sell or develop it themselves in medium term; cinema operator still on board; ACTION: Virginia to keep watch; Paul to search Land Registry

Carwash site (HH): KTNF officers met with architects and developer Douglas Paskin and advised on positive and negative aspects of proposed design; took on ideas discussed; developer and architect have had pre-apps with Camden planners for a ground floor café and three floors of housing above. A planning application to be submitted in New Year.

Regis Road/Murphy site (RW & HH)

Camden has adopted the Regis Road plan in the overall KTNF plan into its local plan. Roger has written to James Murray GLA, Mayor's lead of Housing for a meeting to emphasise importance of Regis Road; forthcoming meeting with Camden planners to discuss the site and developing framework; Camden says it is going to consult widely on this. Murphys yet to release plans.

ACTION: KTRA officers to meet with Katrina Christoforou, Camden Council

Vision for Kentish Town - Transition Kentish Town meeting (IG)

Since inception in 2010, Transition Kentish Town has developed issue based groups and initiatives which turned into other things ranging from social enterprises to Community Benefit Societies (Vegbox, PUNL, CAA) with less emphasis on the local, so a meeting was held to re-emphasise the focus on Kentish Town. TKT is running films on the themes of food (45 attended) and transport, and helping other groups with economy, education and energy topics; regular events to be run in association with the Caversham Practice in the garden and a local urban food group has been set up amongst other things for the new year.

8 Relationship between Neighbourhood Plan and Conservation Areas (CG)

Celia explained the CA concept was 50 years old. There are several CAs in Kentish Town including Bartholomew Estate and Inkerman. Not all CAs are represented on CA Committees. CAs have important role with regard to things like tree preservation, and scrutinise planning applications with regard to conservation area policies and potentially provides a good link to KTNF. CAs could do with more attention in general.

Ingestre Road Assisted Living Scheme, NW5

Proposed scheme: Demolition of the existing elderly persons home and replacement with two blocks of part 4 storey, part 8 storey (western block) and part 5, part 8 storey (eastern block) plus basement excavation to provide an 'Assisted Living'

development of approximately 65 'later living apartments' (circa 40% 1 bed and 60% 2 bed) and provision of ground floor cafe and newsagents open to the general public.
